Re: Application under the Freedom of Information Act 5758-1998 – Request for Information and Figures on the Processing of Applications for Permits to Enter and Exit the Gaza Strip by the Gaza CLA

Ref: Yours dated April 8, 2018, no. 10014

- 1. By way of introduction, it is necessary to point out that the CLA does not have a category for "non-criteria" permit applications. All applications are required to meet the criteria, and the only record of applications that do not meet the criteria is the record of applications denied due to failure to meet criteria. No record is kept of exceptional applications approved *ex gratia* due to security-political or other considerations and based on the specific circumstances of the application, despite not meeting whatever criteria purported in the application.
- 2. In addition, it is noted that the total number of applications relates to each application entered into the computer system, including duplicates and applications entered in error.
- 3. Below please find a list of incomplete/unclear points according to paragraph in your letter:
 - a. The total number of applications submitted to the CLA in 2017 is 133,166.
 The total number of applications submitted to the CLA in 2018 (up to March 31, 2018) is 30,575.

b. We clarify that communications made by lawyers, organizations and associations are not considered applications but public appeals. Hence, there is no disaggregated data according to this criterion.

- g. (g-i) We are unable to produce the statistics requested in these sections as this would require an unreasonable allocation of resources, i.e. reviewing thousands of applications in the system to confirm they were not closed.

In addition, past experience has shown that our process for extracting this datum does not function properly and produces an erroneous result. This is due to the existence of duplicate applications in the same matter with final responses in one not always recorded in the duplicates.

We further note that work is currently underway to restore the process available to us for inquiries regarding the status of pending applications.

- j. The information sought relates to internal operations of a public authority that are irrelevant and unimportant to the public. Therefore, subject to the provisions of Section 9(b)(5) of the Freedom of Information Act, it has been decided not to provide this information.
- k. We note that we do not possess information about permits requested before 2014. The following is a presentation of existing statistics:
